Terms & Conditions for Pre-Qualification of Firms

1. A pay order amount mentioned against each **SEPARATE FOR EACH TENDER** in favour of Principal, Islamabad Model College for Boys, F-10/3, Islamabad is required to be submitted alongwith the tender, failing which tender shall be rejected. In case of successful bidding, this call deposit will be kept as security and would be retained **upto 30.06.2027** i.e. till complete supply / work/ contract and satisfactory report of competent authority; otherwise same will be refunded within 15-days.
2. The articles will be required to be delivered by successful bidder at his own cost without any octroi, transport charges and local taxes at Islamabad Model College for Boys, F-10/3, Islamabad. All repair of / purchases and repair work shall be strictly in accordance with the specifications/ samples/ requirements.
3. Purchases of spare parts and repair work will be on the basis of the lowest rates.
4. The successful bidders will be bound to provide all repair work in the college campus at the required specifications as and when required within the stipulated period, failing which the firm will be penalized amounting to Rs. 10% of the contract amount, (ii) the security amount will be forfeited and (iii) required items will be purchased at the risk and cost of successful bidder and all the expenses so incurred will be recoverable from the said firm/ successful bidder.
5. The use/ supply of sub-standard spare parts is liable to rejection. In such case, the security shall not be refunded nor would this college be obliged for any monetary compensation to the firm concerned.
6. The payment of repeated work /repair will not be payable by the college if the same work occurs during a month.
7. The rates quoted in the tender shall be valid **upto 30.06.2027**. Escalation of rates shall not be permissible on any account during 2025-26.
8. Only such firms are allowed to submit the tender, who are registered with the sales/ income tax department (attach certificate).

9. The list of repair work for which rates have to be quoted is attached. Cutting/ overwriting and altering of rates shall not be considered and will treated as “NIL RATE”.
10. The firm shall produce the samples of the items before supply on the demand of the College Management.
11. Payment shall be made through AGPR, Islamabad. Income Tax/General Sales Taxes etc., as per government rules shall be deducted from the bill/invoice. The administration shall not be responsible for any delay in payment.
12. In unavoidable circumstances, the repair work shall be allowed in firm’s workshop if such could not be arranged technically in the college campus.
