However, if the employer considers the reasons of delay a justified and beyond the control of contractor the time for completion can be extended with imposition of penalty
IT 23	Defect liability period 1. The contractor will be allowed to claim interim payment based on actual work executed at site and duly verified / accepted by the authorized person of the employer. 2. Defect liability period will be one year after completion of work. 3. 5% security will deduct from all running bills of the contractor. 4. 5% security will be retained while finalizing the contract which will be retained till end of defect liability period and the same will be released after the inspection carried out by Divisional Engineer, Assistant Engineer & IOW and their satisfaction regarding occurrence of no defects.
GCC 14.3	Arbitration In case of dispute, CEO/Sr. General Manager will be the arbitrator and his decision will be final and the place of arbitration would be Pakistan Railways Headquarters Office, Lahore.
SCC.3.4	<u>Safety, Security and Protection of the Environment</u> The Contractor shall, throughout the execution and completion of the works and the remedying of any defects therein: (a) Bidder will make security arrangements itself during execution of work. (b) Have full regard for the safety of all persons entitled to be upon the site and keep the site (so far as the same is under his control) and the works (so far as the same are not completed or occupied by the Employer) in and orderly state appropriate to the avoidance of danger to such persons (c) Provide and maintain at his own cost all lights, guards fencing, warning signs and watching, when and where necessary or required by the Engineer or by any duly constituted authority, for the protection of the Works or for the safety and convenience of the public or others and (d) Take all reasonable steps to protect the environment on and off the Site and to avoid damage or nuisance to persons or to property of the public or others resulting from pollution, noise or other causes arising as a consequence of his methods of operation
