SPECIAL CONDITIONS:-

01. The Quotation shall be received at 11:30 Hrs on 16.09.2026 and opened on same day at 12:00 Hrs through EPADs
02. The work force will be allowed to engaged at the site after issuance of service order.
03. The labour will be worked under instruction of the concerned Engineer at site.
04. The payment will only be made by this office on submission of month wise bill after services providing by the labour.
05. All safety measures is the responsibility of contractor to his labour engage at site during the work and ensure adopting all safety measures at work place. JPCL will not be responsible for any loss (injury or what so ever) due to incident occurs because of negligence of day contracotr's worker at site.
06. JPCL reserve the rights to reject all quotations or proposals at any time prior to the acceptance of a bid/proposal as per Rule-33 of the PPRA.
07. No tender without 44509/- (Bid Security) for the tender will be considered. The bidders should deposit bid security Rs. 44509/- as shown against the work in shape of call deposit/pay order in favour of the RE(M) TPS, Jamshoro. The call deposit/pay order should upload along with offered bid on EPAD beside this and the original call deposit/Pay order must be provide to tender opening committee before closing time of tender. The bid will not be considered without original call deposit/pay order and it should be deposited before closing time of tender.

The BOQ prepared in the light of labour and Human Resource Department Karachi Letter vide No. SO(L-II)/13-3/2016-II Dated.17th August,2026 regarding min wages of Un-Skilled @ Rs. 1654/- Per day per Person for 8 working hours. Hence the Bidder must quote the Bid which must be covered the Minimum Wages of Labour of the said notification also cover the Applicable Taxes (i.e income Tax etc).
